

REGULATIONS OF THE "CHRISTMAS TIME" PROMOTION

§ 1. GENERAL PROVISIONS

- 1. These regulations [hereinafter: Regulations] define the promotion rules under the name "Christmas Time" Promotion and is available at www.sdacademy.cz in a format that allows its recreate in the normal course of activities [hereinafter: "Promotion"].
- 2. The Organizer of the Promotion is SDA Czech Republic s.r.o a legal entity duly established and operating under the Czech registered seat in Prague, address: Bílkova 855/19, Staré Město, 110 00 Prague 1, registered in the Ministry of Finance and Economy National Business center with the number 098 63 427, VAT ID: CZ09863427 [hereinafter: SDA or the Organizer].

§ 2. PARTICIPANTS OF THE PROMOTION

- 1. Promotion participants may only be natural persons with full legal capacity, including natural persons running a business, who will conclude an Agreement for the provision of training services with the Organizer in the period from December 12, 2022 to January 6, 2023 until 11:59 p.m. covering one of the following technologies: Java, Python, UX/UI, Java Script, Data Science or Tester [hereinafter: Participant or Customer].
- 2. By concluding an agreement specified in sec. I above under the terms of this Promotion, the Customer declares that:
 - a. is a natural person with full legal capacity;
 - b. has read the content of these Regulations, agrees and accepts its terms;
 - c. undertakes to comply with the provisions of the Regulations;
 - d. consented to the processing of personal data for purposes related to participation in the Promotion on the terms set out in the Regulations.

§ 3. RULES OF PROMOTION

- 1. The Promotion consists in granting the Customers, on the terms set out in these Regulations, a discount on the training service in the amount of 30% of the standard price of the service.
- 2. The specific Promotion rules are as follows:
 - a. if the "Knowledge" package is selected the Participant receives a 30% discount from the standard price for this package;
 - b. if the "Career in IT" package is selected the Participant receives 30% discount from the standard price for this package;
 - c. if the "Career in IT PRO" package is selected the Participant receives 30% discount from the standard price for this package;
 - d. if the "Work guarantee" package is selected the Participant receives 30% discount from the standard price for this package.

§ 4. DURATION OF THE PROMOTION

- 1. The promotion runs from December 12, 2022 to January 6, 2023 until 11:59 PM.
- 2. The order of applications and the date of application shall decide about the participation in the Promotion.



§ 5. COMPLAINT PROCEDURE

- 1. The Customer is entitled to submit a complaint to the Organizer, in particular if, despite the fulfillment of the conditions set out in the Regulations, the Customer does not receive from the Organizer the discount referred to in § 3 sec. 2 of the Regulations.
- 2. Complaints may be submitted within 14 days from the date of the notification by the Customer, as follows:
 - a. in writing to the address of the Organiser's seat; or
 - b. by e-mail to the following address: info@sdacademy.cz
- 3. Complaints will be considered within 30 days from the date of their receipt.

§ 6. PROCESSING OF PERSONAL DATA

- Personal data of Promotion Participants will be processed by the Organizer solely for the purpose of performing the activities necessary for the proper implementation of the Promotion and for concluding contracts for the provision of training services with the Participant.
- The administrator of the Participants' personal data is SDA Czech Republic s.r.o a legal entity duly established and operating under the Czech registered seat in Prague, address: Bílkova 855/19, Staré Město, 110 00 Prague 1, registered in the Ministry of Finance and Economy National Business center with the number 098 63 427, VAT ID: CZ09863427.
- 3. The Participant's personal data in the form of: name, surname, telephone number and e-mail address are processed on the basis of his consent and in order to conclude a contract with the Participant for the provision of training services covered by the Promotion, on the terms set out in the Regulations.
- 4. Personal data referred to in point. 3 above, may be entrusted for processing to postal service providers or marketing agencies acting on behalf of the Organizer, in order to perform the activities necessary for the proper conduct of the Competition.
- 5. Providing personal data is voluntary, however, it is necessary to participate in the Competition.
- 6. The Competition Participant has the right to:
 - a) access your data and correct it, rectify it, delete it, limit it, make it available, transfer it and object to its processing;
 - b) withdrawal of consent to the processing of personal data at any time, but the withdrawal of consent does not affect the lawfulness of the processing which was carried out on the basis of consent before its withdrawal;
 - c) requests from the Organizer to delete their personal data;
 - d) submit a complaint to the supervisory body dealing with the protection of personal data if it is found that the processing of personal data violates the provisions of the general regulation on the protection of personal data of 27 April 2016.

- 8. Personal data of Promotion Participants will be kept by the Organizer only for the period necessary to conclude a contract with the Participant for the provision of training services covered by the Promotion.
- 9. The data is provided on a voluntary basis, and their provision is necessary to cover the Participant with the Promotion.
- 10. Upon deletion of data, the User loses the possibility of being covered by the Promotion.



11. The personal data provided by the Participants is not profiled.

§ 7. FINAL PROVISIONS

- 1. These Regulations will be available for inspection throughout the duration of the Promotion on the Organiser's website www.sdacademy.cz
- 2. The promotion cannot be combined with any other promotions offered by the Organizer.
- 3. The Regulations enter into force on December 11, 2022 and are valid until the end of the Promotion.
- 4. In matters not covered by these Regulations, the provisions of the civil law and other legal provisions shall apply.
- 5. Disputes related to and arising from the Competition will be resolved by the common court competent for the seat of the Organizer, unless generally applicable regulations provide otherwise.
- 6. The Organizer does not use alternative methods of resolving disputes with consumers, unless expressly required by applicable law. The organizer is not obliged to participate in proceedings regarding out-of-court settlement of disputes with consumers. The organizer also informs that the European Commission runs a platform intended for out-of-court filing of complaints and redress. - 7. During the Promotion, the Organizer reserves the right to amend the Regulations covering the amount of the discount granted to Participants or the scope of additional services provided in the price of the purchased package.
